Cost of Wiring & Labor

Cost up to \$2,000.00 = \$40.00 + 3% of total wiring costs

Cost \$2001.00 - \$10,000.00 = \$100.00 + 2% of total wiring costs

Cost \$10,001.00 - 100,000.00 = \$260.00 + 1% of wiring costs over \$10,000.00

Cost over \$100,000.00 = \$1,160.00 + 1/2 of 1% of wiring costs over \$100,000.00

Other Installations

Requested Inspections (of existing wiring)

One (1) hour or less = \$40.00

Over one (1) hour = \$40.00 + \$20.00 for each 1/2 hour or portion thereof in excess of one (1) hour, including travel time

Plan Check

One (1) hour or less = \$40.00

Over one (1) hour = \$40.00 + \$20.00 for each 1/2 hour or portion thereof in excess of one (1) hour

After you receive your electrical permit:

* A copy of the permit is required to be posted at the property location for identification purposes.

* An inspection is required before the power connection can be made. Please refer to the permit number when scheduling inspections and during all correspondence. It is your responsibility, as the property owner, to schedule an appointment 24 hours in advance of an inspection when:

- A. You are ready to power
- B. The electrical rough-in is completed (before installing or covering)
- C. The electrical work is finished and a final inspection is desired

* The Electrical Inspector is authorized to inspect, re-inspect or test any electrical installation. If, at any time, the Electrical Inspector finds that the work which had been completed does not meet applicable safety codes, you will be notified, in writing, of the corrections to be made and the specified time for completion. Once the corrections have been completed, please call for re-inspections, (208) 612-4021.

Address of property must be provided and visible on the property before any inspection will be made. If address is not posted on property, the inspection will not be made.
